[The students of Medical College are required to do internship at the end of their course. The College has created huge infrastructure for the hospital which has resulted in increase in patients visiting the facility to seek medical consultation. The College has created this huge infrastructure and the resulting patients' inflow to provide enough material to the students to do their internship. However, the college has observed that many students chose to do internship at other colleges and the infrastructure lies under-utilized for internship.

In order to desist the students from taking up internship at other colleges and encourage the students for doing internship at its facility, the College had decided to increase the fee for issuing No-Objection Certificate to the students seeking to do internship at other college from Rs. 16,000/- to Rs. 60,000/- all inclusive. The Committee is requested to ratify the decision of the college.

Further, if this increase in No-Objection Certificate fee does not act as sufficient deterrent to the students, then it is recommended to further increase this fee up to a maximum of Rs. 3,00,000/- all inclusive, in the academic year 2018-19.]

Patil Vidyapeeth campus, it is proposed that a committee consisting of four members viz (1) Dean of concerned Faculty (Chairman) (2) one expert from outside (3) The Registrar or his representative (4) Director (Research) be appointed. The committee will visit and submit the report, to the Vidyapeeth that whether such place is well equipped and suitable for research and the candidate can do the research work at that place. For that limited purpose, such place (Hospital or Laboratory or Institute) be recognized as Research Centre for that candidate only. The fee of Rs. 15,000/- (Rupees Fifteen Thousand only) within Pune and Rs. 25,000/- (Rupees Twenty Five Thousand only) outside Pune but within Maharashtra be prescribed as Recognition Fee. Such Inspection fee should be paid by the concerned Institute to the Vidyapeeth. However, such fees can be waived off, depending upon case to case basis, for institutes which are recognized by other universities / DNB Board / CPS Board / Central or State authorities, etc. The Vice Chancellor has accepted the above proposal on behalf of the Board of Management]

Resolution No. BM-12(i)-18: It was resolved that the action taken by Vice Chancellor of accepting proposal of charging Recognition Fee of Rs.15,000/- for the recognized Research Centre within Pune and Rs.25,000/- for recognized Research Centre outside Pune but within Maharashtra for conducting research work of Ph.D. Scholars, be noted. It was further noted that such fees can be waived off, depending upon case to case basis, for institutes which are recognized by other universities / DNB Board / CPS Board / Central or State authorities, etc.
