Dr. P. N. Razdan, Hon'ble Vice-Chancellor, welcomed all the members of the Board of Management.

Hon'ble Vice Chancellor informed the house about the result of NAAC Peer team visit held in the month of January, 2015, that the Standing Committee of



Executive Committee of NAAC has considered the NAAC Peer team report and awarded the Vidyapeeth "A" grade with CGPA of 3.62 on 4 point scale.

Vice Chancellor also informed the house that ours is the 7th University in the country & the 3rd in the Deemed Universities in the rank of NAAC ratings. Furthermore we share the top position with CGPA of 3.62 on 4 point scale amongst health science universities of the country.

Members of the Board of Management resolved that Hon'ble President, Hon'ble Chancellor, Hon'ble Vice Chancellor, all teaching faculties, non-teaching staff and students be congratulated for their contribution in achieving the outcome.

Item No. BM-02-15: To consider the report on the 'Actions Taken' by the Vidyapeeth office on the resolutions of the Board of Management.

Resolution No. BM- 02-15: Resolved that, the report of 'Actions Taken' on the resolutions of the last meeting of the Board of Management was noted and approved.

As per recommendations of Planning and Monitoring Board and approval of Board of Management vide its resolution No. BM-40-14, it was resolved that Certificate Course of Geriatric Dentistry be started under Faculty of Dentistry. Accordingly, the Dean, Faculty of Dentistry, informed the Board that the Certificate Course of Geriatric Dentistry is being started in the Dental College from the Academic Year 2015-16, the details of which are as follows:

Item No. BM-05(i)-15: Revision of MBA (Hospital & Healthcare Management) syllabus from the Academic Year 2015-16 onwards.

Resolution No. BM-05(i)-15: It was resolved that the modifications in the MBA (Hospital & Healthcare Management) syllabus from the Academic Year 2015-16, be approved.

Item No. BM-05(ii)-15: Consider Examination Pattern for 2 Years MBA Programme through Distance Learning.

Resolution No. BM-05(ii)-15: It was resolved that if any student fails to get a pass score in the term end examination of 2 year MBA distance mode programme, the candidate shall be eligible to reappear at the next term end examination as and when it is held, within the total span of the programme (i.e. maximum of 4 years) be approved.

Item No. BM-06-15: To consider following recommendations made by the Academic Council at its meeting held on 13th March, 2015 related Faculty of Allied Medical Sciences.

Item No. BM-06(i)-15: Implementation of Semester System and Choice Based Credit System for BPT and MPT programmes and to finalize subject nomenclatures of the same.

Resolution No. BM-06(i)-15: It was resolved that the Semester System and Choice Based Credit System be introduced in the BPT and MPT Programmes from the Academic Year 2015-16 onwards.



The course structure of revised BPT and MPT syllabus with semester and choice based credit system and subject nomenclatures of the same is annexed hereto as Appendix – VII.

Item No. BM-07-15: To consider adoption of "Double Evaluation System" for UG Answer Papers.

Resolution No. BM- 07-15: After consideration of recommendations of Board of Examinations and Academic Council, it was resolved that average marks of the total marks given by two examiners be considered for final computation of the result and such average marks shall be the marks obtained by the concerned examinee for the particular Paper / Subject, as applicable.

It was further resolved that if there is a difference of more than 20% marks between the two Examiners, the said paper be evaluated by the third Examiner and the average marks of the higher closer two Examiners' marks shall be considered as final marks. The detail procedure of Double Evaluation system is annexed hereto as Appendix - VIII.

It was also resolved that this double evaluation system will come into force from the Academic Year 2015-16 i.e. from the examination session of Oct./Nov./Dec. 2015 onwards.

Item No. BM-08-15: To consider recommendations of the Academic Council for the award of Degree / Diploma Certificates to the eligible candidates in the various faculties.

The Sixth Convocation of Dr. D. Y. Patil Vidyapeeth, Pune is scheduled to be held in the month of May/June, 2015. There are 755 eligible candidates to receive their Degree / Diploma Certificates in the ensuing Convocation.

Resolution No. BM-08-15: It was resolved that the award of Degree / Diploma Certificates to the 755 eligible candidates in the various Faculties, during the



Sixth Convocation be approved. The Faculty wise details of 755 eligible students are annexed hereto as Appendix – IX.

It was further resolved that till the Convocation 2015 of the Vidyapeeth held, if any candidate become eligible for award of Degree, the Vice Chancellor be authorized to accept the same on behalf of the Board of Management and the said degree be awarded to him/her in Convocation 2015.

Item No. BM-09-15: To approve awarding Gold Medal to Nineteen (19) candidates for obtaining highest marks in their respective programmes at the Sixth Convocation of the Vidyapeeth.

The Sixth Convocation of the Vidyapeeth, Pune is being scheduled in the month of May/June, 2015. There are total Nineteen (19) candidates who will be awarded Vidyapeeth Gold Medals for obtaining highest marks in their respective programmes.

Resolution No. BM-09-15: It was resolved that award of Gold Medals to Nineteen (19) candidates for obtaining highest marks in their respective programmes at the Sixth Convocation or the Vidyapeeth be approved. - 1. Budget review committee to be appointed which need to review the budget quarterly.
- 2. Institute wise note regarding utilization of budget and plan of action should be prepared justifying any increase in the budget estimates and it should be attached with individual institution's budget copy.
- 3. All constituent colleges / institutes of Vidyapeeth should concentrate on more Research Projects to be funded by outside agencies i.e., DST, ICMR & MHRD etc instead of depending only on DPU funding for research.

Item No. BM-10(iv)-15: To approve the Fees for UG and PG courses of Constituent Colleges / Institutes for the academic year 2015-16.
