The objectives, structure and salient features of Electives are as follows:

#### **Electives:**

#### **Objectives:**

To provide the learner with opportunities:

- (a) For diverse learning experiences,
- (b) To do research/community projects that will stimulate enquiry, self-directed, experiential learning and lateral thinking.
- Two months are designated for elective rotations after completion of the examination at end of the third MBBS Part I and before commencement of third MBBS Part II.
- It is mandatory for learners to do an elective. The elective time should not be used to make up for missed clinical postings, shortage of attendance or other purposes.

#### Structure

(a) The learner shall rotate through two elective blocks of 04 weeks each.

- (b) Block 1 shall be done in a pre-selected preclinical or para-clinical or other basic sciences laboratory OR under a researcher in an ongoing research project. During the electives, regular clinical postings shall continue.
- (c) Block 2 shall be done in a clinical department (including specialties, superspecialties, ICUs, blood bank and casualty) from a list of electives developed and available in the institution OR as a supervised learning experience at a rural or urban community clinic.
- (d) Institutions will pre-determine the number and nature of electives, names of the supervisors, and the number of learners in each elective based on the local conditions, available resources and faculty

#### **Description of Curricular program**

Two choices of electives are offered to medical students before the commencement of III MBBS part 2. For the purpose of this document these shall be called Block 1 and Block 2.

Dr. D. Y. Patil College of Ayurved & Research Centre, Pimpri, Pune and Dr. D. Y. Patil Homoeopathy Medical College & Research Centre, Pimpri, Pune have come under the ambit of Dr. D. Y. Patil Vidyapeeth Pimpri, Pune from the Academic year 2018-19 onwards. Both the colleges have Undergraduate (UG) programmes of 4 ½ years plus one-year Compulsory Rotatory Internship and Postgraduate (PG) programmes of 3 years duration. The first PG batch of Ayurved (MD/MS) and Homoeopathy (MD Hom.) programmes will pass out in the year 2021. The first UG batch of Ayurved and Homoeopathy (BAMS/BHMS) programmes will pass out in the year 2023.

As per the norms/conditions prescribed for the Gold Medal of P.G. examinations, the Gold Medal is awarded to the topper among the subjects, having obtained marks not less than 65% marks in aggregate. For undergraduate Examination, the Gold Medal is awarded to the topper of Final Year examinations.

Revised development receipts projection for F.Y. 2020-21 is Rs. 73.52 Crore and the revised development expenditure projection is Rs. 71.25 Crore leaving a surplus of Rs. 2.27 Crore.

Accordingly, the revised budgetary deficit is Rs. 1.52 Crore. This revised net deficit projection on account of reduction in projected IPD/OPD receipts and interest on deposits. Under current COVID situation, it is proposed to meet this deficit through better utilization of resources, increase in consultancy revenue and adopting cost benefit approach while incurring expenditure. In view of the above, the above-mentioned proposed budget revision for FY 2020-21 was approved.
