Dr. D.Y. Patil Vidyapeeth, Pune (DPU) has implemented a comprehensive DPU-ERP system developed in-house to manage all academic and administrative functions. 15. Multidisciplinary / interdisciplinary

Vision and Strategic Planning: Dr. D. Y. Patil Vidyapeeth has taken active steps to align with the goals of the National Education Policy (NEP) 2020. As a health science university with 13 faculties adhering to regulatory standards, it has set up a high-level committee tasked with developing a vision and action plan. This committee focuses on identifying opportunities for multidisciplinary and interdisciplinary courses for providing

holistic education to the students besides ensuring they meet statutory requirements. Institutional Strategy: Though Dr.D.Y. Patil Vidyapeeth is a Health Sciences University, subsequent to NEP 2020, the Vidyapeeth has implemented programs in Humanities and sciences with STEM subjects. These programs are offered by establishing School of Liberal Arts, School of Science and Technology, School of Design and School of Allied Health Sciences to enhance its multi-faculty and multi- disciplinary structure. These units support the integration of Health Sciences with humanities, STEM fields by offering courses like Dance, Drama, Music and Choreography across various faculties. Flexible and Innovative Curriculum: Following AICTE and UGC standards, the Vidyapeeth has adopted a flexible, credit-based curriculum in departments such as Biotechnology and Bioinformatics, Global Business School, College of Physiotherapy, Institute of Optometry and Visual Sciences, College of Nursing, and Schools of Liberal Arts, Design, Science, and Technology. Unique programs, including Data Science, Artificial Intelligence, Bachelor of Design, Bachelor of Applied Arts & Craft, and Bachelor of Science, provide flexibility through the credit system. Further the Competency Based Curriculum launched by NMC, NCH, NCISM, INC is implemented that provides flexibility by way of offering electives. Program Duration and Exit Options: Programs within the Schools of Liberal Arts, Design, Science and Technology, and Allied Health Sciences span four years, with provisions for lateral entry and multiple exit points as envisioned in NEP 2020. The university awards certificates, diplomas, degrees, and honours after one, two, three, and four years, respectively, with defined skill components for each stage. Multidisciplinary Research Initiatives: Faculty from various fields collaborate on numerous research projects. A key example is the Consortium for Cancer Studies, which brings together faculty from Biotechnology, Medical College, Dental College, and partner hospitals, and collaborates with national institutions like NCCS and IISER. Various department across different colleges conduct interdisciplinary research in different faculties. Internationalization Efforts: In line with NEP 2020, the Vidyapeeth promotes multi-faculty structures, four-year programs, credit-based curricula, and internationalization. As mandated UGC guidelines 2021, the university has established Office of International Affairs and at its constituent units. This office takes care of credit exchange, credit transfer through MOU's with universities like Skovde and Orebro Universities in Sweden, enabling students to participate in semester-abroad programs. Additionally, the Vidyapeeth fosters international research collaborations and web-based learning, exemplified by its

partnerships with Johns Hopkins Medical School in the USA for faculty and student exchanges in its Medical and Nursing colleges.

16.Academic bank of credits (ABC):

At Dr. D. Y. Patil Vidyapeeth Pune, the Academic Bank of Credits (ABC) is based on the National Academic Depository (NAD), which serves as the primary repository for storing student's academic achievements and information. The Vidyapeeth has taken steps to register over 28,000 students on ABC portal and 13,500 credits have been uploaded. Aligning with NEP 2020, the Vidyapeeth emphasizes a holistic student development approach-covering intellectual, aesthetic, social, physical, emotional, and moral aspects-by incorporating IKS and multidisciplinary subjects. To address students' challenges and promote self-reliance over dependency on government jobs, the institution is developing short-term and vocational courses. It emphasizes multidisciplinary subjects, sets clear program learning outcomes, and defines course and unit-specific learning outcomes detailing the knowledge, skills, attitudes, and values students are expected to gain. The Vidyapeeth has set up digital repositories for credit storage and issuance, along with a peer-to-peer credit transfer framework to implement ABC effectively. This includes transparent evaluation protocols for various types of credit transfers, credit redemption and credit conversion managed by dedicated examination department responsible for assessment, tracking, and managing student records within ABC. ABC acts as a resource for faculty to verify student's credits, with students creating an account by submitting personal and course details. A unique APAAR ID and password allow students to access their credits, aligned with UGC guidelines. Currently, ABC promotes an interdisciplinary and multidisciplinary approach. DPU supports students' subject choices, aiming to produce "skill-oriented" graduates. Programs include a four-year multidisciplinary bachelor's degree with options for lateral entry and multiple exits, designed to equip students with specific job-ready skills. Students have been instructed to register on DPU's ERP system, which has been updated to support multiple entry and exit points. They are encouraged to enrol in SWAYAM, NPTEL, IKS and MOOCs for additional credits.

17.Skill development:

Aligned with the National Skills Qualification Framework (NSQF) of NEP 2020, Dr. D. Y. Patil Vidyapeeth (DPU) is committed to shifting from content-heavy, rote-based curricula to a model

focused on deep conceptual understanding and essential professional skills. This holistic approach integrates a creative, multidisciplinary curriculum that connects STEM subjects with humanities, sports, fitness, languages, culture, and the arts. DPU emphasizes the development of soft skills-such as communication, teamwork, problem solving, Leadership etc-essential for shaping students into global citizens. The Directorate of Student Training and Development at DPU is dedicated to fostering these life skills. As a Health Science University, DPU provides program-specific skills training through advanced resources like skills and simulation laboratories and robotic surgery training. The curriculum includes training in clinical skills (psychomotor and affective domain skills), with ICMR -Short Term Studentship (ICMR-STS) and DPU-STS projects enhancing analytical and innovative skills. Colleges within the Vidyapeeth, such as dental, nursing, physiotherapy, ayurveda and homoeopathy focus on developing clinical skills through models, simulations, and mock-ups. To develop and strengthen research skills at early stage we have also introduced UG Research Promotion policy. Students' progress from foundational knowledge to supervised hands-on experience with real patients, building diagnostic and management skills for increasingly complex cases. Practical skills are reinforced through procedures in Skills and simulation labs, operation theatres and Intensive Care Units (ICU). Industry-oriented programs in Biotechnology and Business Schools include industrial training, internships, and regular seminars, symposia, and workshops under 'Industry-Academia' initiatives. DPU takes a comprehensive approach to enhancing analytical skills, personal and professional development, and employability skills. Project-based learning enables research, dissertations, summer training, and industrial experiences. Humanitarian values are reinforced through events and workshops on human values, professional and biomedical ethics, communication, interpersonal skills, gender sensitization, stress management, Yoga , wellness and personal guidance. Role plays are utilized to teach communication skills, ethical and social issues, patient counselling, and gender sensitivity. NEP 2020 guidelines have transformed DPU's curriculum, embedding a competency-based approach across programs.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The global knowledge system has led to significant advancements in science and technology, causing profound societal changes that have eroded longstanding value systems and beliefs. India, with

its rich cultural heritage spanning thousands of years, is a repository of diverse expressions such as arts, literature, customs, traditions, linguistic nuances, artifacts, and heritage sites. At Dr. D.Y. Patil Vidyapeeth, Ayurveda College serves as a platform for the application of traditional treatment methods, Yoga, and Wellness therapies based on ancient knowledge systems. This institution has taken deliberate steps to incorporate Indian knowledge derived from Sanskrit scriptures and traditional practices, including Yoga and meditation, with a holistic approach that integrates both body and mind. The teachings and practices adhere to the traditional way of life, as elucidated in the concept of Dincharya. The crucial aspect of healthy living, as outlined in our scriptures by Acharyas in the form of Achar Rasayana, is deeply embedded in our curriculum. It is imparted to students and implemented in clinics for the benefit of patients. Ayurveda places significant emphasis on diet (Ahara). Our institute actively promotes lectures to educate on the adoption and adherence to dietary culture, following the rules outlined in classical texts. Additionally, a Basic Short-Term course in Ayurveda Ahara (Nutrition) is offered. Preservation of traditional knowledge necessitates a focus on its vernacular language. Our institute offers a Value-Added Course called "Vadatu Samskrutam," teaching Sanskrit for Samhitas. The classes are conducted in English to facilitate better understanding and dissemination of traditional knowledge worldwide, with students from Brazil, USA, Canada, and Spain actively participating. Our institute also offers a basic course in Marma Sharir, focusing on traditional knowledge concerning specific energy points on the body, considered as conglomeration of anatomical structures. This course has diverse applications in various therapies. Both Certificate and Basic courses are offered in Panchakarma, a specialized Ayurvedic therapy involving internal bio-purification and rejuvenation. This therapy, with its traditional protocols, not only provides prevention and cure for various health concerns but also delivers visible relief from diseases. The institute offers diploma courses in Yoga, preserving the lineage of Patanjali, the pioneer of Yoga, and Transcendental Meditation Courses. Pre-natal and ante-natal (Garbhasanskara) care, from conception to delivery, is a key characteristic of Ayurveda, and the Streerog avum Prasuti department of DPU provides courses in Garbhasanskara for ensuring healthy progeny and a prosperous society. Furthermore, a Value-Added Course in Ayurvedic Cosmetology is conducted, designed to use traditionally beneficial herbal formulations innovatively. The daily classroom teaching commences with the chanting of Dhanvantri Srotram and Saraswati Vandana in Sanskrit, and the teachings of the Bhagavad

Gita are also integrated, thus providing a comprehensive immersion in traditional knowledge.

19. Focus on Outcome based education (OBE): Focus on Outcome based education (OBE):

Outcome-Based Education (OBE) is a student-focused approach that strategically aligns course delivery and assessment methods with specific learning goals and desired outcomes. The core emphasis of OBE is to assess students' performance in terms of the skills and competencies they gain by the end of the program. This approach shifts from the traditional teacher-centered model to a learner-centered model, empowering students to choose "why and how" they want to learn. At Dr. D. Y. Patil Vidyapeeth (DPU), an outcome-based framework has been developed, incorporating curriculum enrichment and skill-building components to support effective learning. The process begins with defining desired outcomes, designing an outcome-oriented curriculum, choosing appropriate teaching methods, and setting up an assessment strategy to measure learning achievements. Faculty members serve as co-learners and mentors, fostering critical thinking, problemsolving skills, and higher-order learning, which includes analysis and synthesis. DPU has established clear, measurable Program and Course Outcomes, aligning teaching, learning, and assessment with these outcomes. The implementation of OBE involves mapping syllabus content and lesson plans for each lecture, accessible to students and staff through the DPU Learning Management System (DPU-LMS). Formative and summative assessments ensure continuous quality improvement in achieving outcome competencies. Feedback from stakeholders and regulatory quidelines inform curriculum revisions, new courses, and valueadded programs. Each institute conducts detailed outcome analysis, with results presented to the Board of Studies (BoS) and Academic Council, showing promising examination outcomes across faculties. Exams at DPU are structured not only to assign grades but also to evaluate competency outcomes achieved through practical exercises, viva, presentations, and group discussions. Assessment methods include term papers, open-ended problemsolving tasks, multiple-choice questions (MCQs), and short-answer questions (SAQs), ensuring alignment with learning outcomes. Continuous monitoring of learning outcome attainment is based on scientifically validated methods and interpretations, with evidence documented in clinical contexts.

20.Distance education/online education:

Dr. D. Y. Patil Vidyapeeth offers vocational courses through Open Distance Learning (ODL) to provide flexibility for students.

Faculty members use digital tools like Google Classroom and Zoom, along with video resources, to support instruction. Blended learning strategies at the institution include group collaborations, interactive assignments, and regular assessments. The program uses a multimedia instructional approach, combining self-learning materials, audio-visual aids, teleconferencing, counseling, seminars, workshops, and online sessions tailored to student needs. Teleconferencing is particularly used to improve comprehension and clarity for learners. A digital content repository has been developed, featuring coursework creation, learning games, simulations, augmented reality, and virtual reality to provide immersive learning experience. Accessible tools, including apps and gamified content in multiple languages, have been designed with clear instructions to support students. Faculty members have received extensive training in learnerfocused pedagogy and online content creation using various teaching platforms. The emphasis is on enabling teachers to actively engage students with course materials. Online applications offer quizzes, competitions, assessments, enrichment content, and resources such as smart classrooms and online communities, enhancing the teaching-learning process with digital tools and collaborative online resources.

The Board of Examinations (BOE) plays a vital role in ensuring the integrity and efficiency of the examination process in higher education. To achieve this, the BOE has introduced several reforms aligned with the National Education Policy 2020 (NEP-20), Sustainable Development Goals (SDG), and guidelines from statutory bodies like NMC, DCI, AICTE, AYUSH and UGC.

Key Reforms Introduced:

- · Competency-Based Medical Education (CBME): Implemented CBME Regulations 2023 for the MBBS program, focusing on competency-based curriculum. These reforms offer elective courses to the students facilitating interdisciplinary learning.
- Post Graduate Medical Education Regulations: Introduced new syllabus and examination patterns for PG Medical programs, emphasizing outcome-based education.
- Reforms in BAMS and BHMS Programs: Implemented new syllabi for 2nd Professional BAMS and II BHMS Professional programs, aligning with the latest regulations of AYUSH.

- Four-Year BBA (Honors) Programs: Introduced four-year BBA (Honors) programme with provision of multiple entry/exit options.

DPU has integrated graduate attributes and learning outcomes into its curriculum, aligning with regulatory guidelines. These essential components are accessible on the University website and effectively disseminated through ERP, mentorship booklets and displayed in the classrooms and library.

Graduate Attributes (GAs) define the overarching capabilities students should acquire, while Program Outcomes (POs) demonstrate graduates' skills, knowledge, and attitudes. Standardized POs across all programs encompass knowledge, skills, planning, problemsolving, communication, research aptitude, professionalism, ethics, societal responsibilities, and lifelong learning. A comprehensive mapping of Course Outcomes (COs) to POs has been executed, utilizing Bloom's taxonomy to align content and ensure congruence between assessment methods and learning outcomes.

Continuous assessment methods, as outlined in the Attitude, Ethics and Communication module (AETCOM) module and CBME curriculum, employ diverse approaches, including open-ended problem-solving assignments, MCQs, LAQs, SAQs, case studies, OSCE/OSPE, laboratory tests, viva-voce examinations, presentations, group discussions, and formative assessments. These methods, alongside workplace-based activities, are designed to evaluate the attainment of learning outcomes meticulously.

Examinations play a pivotal role in assessing whether predefined learning outcomes have been achieved at desired levels. They significantly contribute to evaluate the attainment of both POs and COs.

3.3 - Innovation Ecosystem

Dr. D.Y. Patil Vidyapeeth (DPU) established the DPU Foundation for Innovation Incubation & Entrepreneurship (DPU-FIIE) under Section 8 of the Companies Act 2013 to foster an environment of innovation and support internal startups. The foundation facilitates students and faculty in applying for copyrights and patents, with each constituent unit hosting its own Institute Innovation Council (IIC) in line with the Ministry of Education's Innovation Cell (MIC) guidelines. The Start-up and Innovation Cells across institutes regularly conduct activities that contribute to the Vidyapeeth's IIC performance evaluation. Notably, DPU secured a prestigious 4-star rating in the Annual IIC 5.0 Performance (AY 2022-23) and hosted the IIC Regional Meet in December 2023, graced by eminent leaders including Dr. Abhay Jere, Vice Chairman (AICTE), and Dr. Shekhar Mande, former DG, CSIR.

Recognized as a top-performing university in the Western Zone for innovation, DPU encourages the development of new products, processes, and knowledge through regular Start-up and Innovation Cell meetings. In the past year, DPU has achieved significant milestones with 101 copyrights and 44 patents filed and published. Additionally, the institution promotes social entrepreneurship to nurture socially responsible healthcare professionals, building a robust ecosystem for innovation and entrepreneurship.

The IPR (Intellectual Property Rights) Cell of Vidyapeeth has been operational since 2019, following the approval of the Board of Management resolution BM-20-16. The Vidyapeeth, along with its constituent units, is dedicated to equipping students with essential knowledge and skills, promoting growth and innovation in their respective fields.

The IPR sessions have not only highlighted the importance of safeguarding intellectual assets but also provided a thorough understanding of patent laws and strategies for effective protection. In the academic year 2023-23, the Cell conducted series of workshops on IPR, aimed at nurturing a culture of protecting intellectual property through regular patent, copyright, and design filing processes.

Additionally, discussions on Research Methodology helped participants gain a deeper understanding of scientific methodologies, ensuring rigor and validity in their research endeavours. Emphasizing Good Clinical Practice (GCP) reinforced the ethical standards crucial in clinical research. During 2023-23, a total of 24 workshops were conducted on Good Clinical Practices and skill development and Research Methodology, were held. A feedback mechanism has been established to identify future opportunities for enhancing the culture of innovation and research at Vidyapeeth.

3.5 - Consultancy

3.5.1 - Institution has a policy on IPR and consultancy including revenue sharing between the Institution and the individual, besides a training cum capacity building programme for teachers, students and staff for undertaking consultancy

The IPR and Consultancy Policy, endorsed through BoM resolutions BM-26-16 and BM-39-18 and accessible on the Vidyapeeth website, aims to foster academic progress and promote initiatives in advanced sciences and human well-being. This inclusive policy applies to all academic community members, including faculty, students, and research scholars.

The policy outlines intellectual property (IP) guidelines, asserting Vidyapeeth's ownership of IP developed using its resources while allowing authors to retain copyright for original works and benefit financially under specified conditions. For patents, inventors retain rights until protection terms are established collaboratively with the University, which may pursue sales, licensing, or technology transfer. Revenue generated from these activities is shared based on predefined royalty agreements.

Faculty contribute significantly by offering consultancy services to external organizations and industries, enhancing research credibility and practical applications. During AY 2023-24, consultancy projects, including clinical trials, generated Rs. 143.33 lacs in revenue. Vidyapeeth's Consultancy Policy provides a structured framework to ensure these services align with institutional goals. These engagements have fostered research, scholarly exchanges, and practical solutions to real-world challenges, reinforcing economic and societal progress. Faculty members are instrumental in knowledge and technology transfer, driving impactful innovations that benefit both the academic community and society at large.

Its courses incorporate hands-on field experience at Primary Health Centers, Urban Health Centers, and Rural Health Training Centers, providing practical healthcare learning. The institution actively participates in social responsibility programs, including the Swachh Bharat Abhiyan with 10 swachata seva activities, the Unnat Bharat Abhiyan, and 64 National Service Scheme activities focused on sanitation, environmental protection, and healthcare in adopted villages.

A key initiative, the Human Milk Bank, has benefited 2,072 mother

donors and 2,781 babies, significantly reducing morbidity and mortality. Rural Satellite Health Centers conduct regular clinics at Rural Health Centers and Urban Health Centers. - 4.1.1 The Institution has adequate physical facilities for teaching –learning, skills acquisition etc.
- Dr. D. Y. Patil Vidyapeeth, Pune, situated on a spacious 42.5-acre campus in Pimpri and Tathawade, within the Pimpri-Chinchwad Municipal Corporation. Area of 703 sq. meterwas newly constructed in Dental building for Pre-Clinical laboratory and Fellowship program.

The institution's teaching-learning infrastructure is robust and aligned with accreditation standards, offering a technologically

advanced environment to support diverse pedagogical approaches. It features 94 ICT-enabled classrooms, including smart classrooms, 49seminar halls, and 150 demonstration rooms, ensuring an enriched learning experience. The inclusion of two well-equipped auditoria further elevates the quality of educational delivery.

Clinical learning is enriched by the availability of 2011 beds in Medical, 325 beds in Ayurved, 43 in Homoeopathy, and 425 dental chairs. These resources ensure comprehensive bedside clinical teaching and learning. The institution extends its educational reach into the community through ten Satellite Health Centers, covering both rural and urban areas. In compliance with regulatory standards, the institution surpasses requirements in providing facilities such as museums, skill labs, and an Animal House registered under CPCSEA. The Animal House, approved on 14/02/2017 (R.No.619/PO/02/ReBI/S/02/CPCSEA), is meticulously maintained by the Department of Pharmacology.

The AYUSH Related Learning Cum Therapy Center integrates Ayurveda and Homoeopathy treatment modalities, offering diverse treatments during multi-diagnostic camps. The in-house Ayurved pharmacy, 'Sudhatatava,' holds GMP certification (MH/PZ3/GMP/6095400). In essence, the institution's physical facilities align with and surpass the stringent standards set by regulatory bodies, fostering a scientifically enriched educational ecosystem.

Recreational facilities - Two Auditoriums are available with 1000 and 250 Capacity respectively that are used for cultural and other student activities.

Medical tourism has been started and Superspeciality services are existing with latest global standards.

Dental Hospital: It is NABH accredited with 425 dental chairs and state-of-art Dental Implant Center facilities that are used in imparting quality education to the students.

Ayurveda Hospital: It is NABH accredited with 325 beds and excellent Panchakarma Facility. Pharmacy manufactures Ayurvedic medicines and variety of Cosmetics/ Nutraceuticals for OPD/IPD patients.

Homeopathy Hospital: The well-equipped hospital (43 beds) is NABH accredited.

Physiotherapy Services: OPD is equipped with latest therapeutic modalities to provide best possible care with great safety and efficiency.

Nursing Services: It is a part of Medical Hospital to satisfy the health care needs of the patients.

Institute of Optometry and Visual Sciences: In-house clinical services are offered.

Laboratories: The Vidyapeeth's constituent units house a total of 1241aboratories. Among them, the CCL, Microbiology, Pathology, and Molecular Diagnostic Laboratories hold NABL accreditation. Additionally, a 5G laboratory has been established at the School of Science College.

Equipment: Vidyapeeth has procured sophisticated equipment for teaching hospitals to enhance facilities required by faculty, students and stakeholders.

The teaching hospitals at Dr. D. Y. Patil Vidyapeeth demonstrate

adequacy in both outpatient (OPD) and inpatient (IPD) services across the Medical, Dental, Ayurveda, and Homeopathy facilities. These figures adhere to the norms outlined by regulatory authorities, surpassing minimum requirements. In the academic year 2023-2024, the OPD treated 19,10,957 patients, while the IPD accommodated 2,04,083 confirming to the dedicated healthcare services provided.

Surgical suites in both hospitals are well-equipped for major and minor surgeries, averaging 87 procedures monthly, with the added capability of live telecasting. Each day witnesses approximately 8,775 Pathology, Biochemistry, and Microbiology investigations, alongside 1,166 radiological investigations, highlighting the hospitals' diagnostic prowess.

The implementation of a comprehensive Hospital Information Management System (HIMS) by the Software Development Cell (SDC) ensures streamlined healthcare administration. Students across medical disciplines undergo training in HIMS, integrating technology seamlessly into their education. Clinical postings, including multi-specialty rotations, offer hands-on training, incorporating case studies, presentations, seminars, bedside teaching, and patient management. Regular training sessions familiarize students with various HIMS modules, enhancing their proficiency in utilizing cutting-edge healthcare technology. This dynamic approach ensures that students receive a well-rounded, technology-driven clinical education in line with contemporary healthcare practices.

4.3 - Library as a Learning Resource

DPU boasts a cutting-edge Learning Resource Centre abundant with an extensive collection of books, journals, e-books, e-journals, and E-databases tailored to support educational and research needs. The ILMS software utilized includes an OPAC and the internally developed DPU-ERP [Version 3], offering complete automation, which commenced in 2014 and concluded in 2018. The institution has diligently ensured top-tier library resources

across all constituent units. Additionally, each department maintains its own dedicated library.

Subscriptions for reputable print and e-journals are available in all libraries. They also have access to renowned databases like EBSCO HOST, SCOPUS, J-GATE, KNOWLEDGE HUB, ELSEVIER CLINICALKEY, and CLINICALFLEX STUDENT. These databases enable searches based on title, subject, author, publisher, and keywords. Every constituent unit operates its own Library Committee, regularly refreshed and reconstituted. This committee convenes at least biannually, contributing recommendations concerning new acquisitions, library organization, facility enhancements, and related matters. Biometric attendance system records the entry and exit of all library users, while a Radio Frequency Identification (RFID) system serves for both registration purposes and as a security measure against theft.

Library Services encompass various offerings such as access to reference materials, lending services, electronic information retrieval, browsing capabilities, photocopying facilities, on-demand book provisions, book exhibitions, new arrivals showcase, and reader awareness programs.

All constituent units have made certain that students have access to top-notch library resources, following an Open Access system. In the academic year 2023-2024, the library enriched its collection by incorporating a total of 4640 textbooks and 5454 reference books. The collection of ancient books includes publications from vintage years, special editions, first

printings, out-of-print editions, original manuscripts, and literature related to traditional Indian medical systems. To benefit students and faculty, crucial links to ancient and traditional books have been provided on DPU's library portal. The continuous pursuit of acquiring knowledge resources to enhance the library's offerings remains ongoing. Additionally, each department within the constituent units maintains its specific library resources aligned with their disciplines.

Data Centre provides comprehensive technical IT support including software development, procurement and maintenance of hardware and liaising with software providers. The DPU has about 2389 computers and 65 smartboards utilized exclusively for academic purpose by the students and the faculty members The computer facility in the library is utilized effectively by students for accessing e-learning resources from morning till evening.

Regular up-gradation of IT infrastructure has ensured high speed connectivity to these computers that are readily available to the faculty members and students. Hostels are also having Wi-Fi connectivity. Up-gradations: Wi-Fi services are available in classrooms, library and all the buildings of the Vidyapeeth. The classrooms have been upgraded with interactive display boards/ TVs making learning more effective. In addition, audio-video recording facility has been created for the development of e-content. The e-content is then uploaded on Vidyapeeth portal for access by the students for learning. The installation of Hypervisor i.e. (Virtualization) has converted physical server into multiple virtual machines for each database module eliminating future purchases.

4.4.4 - Facilities for e-content development such as Media centre, audio visual centre, Lecture Capturing System (LCS), etc.

With its state-of-the-art media centre and lecture recording capabilities, DPU allows professionals to create educational content in electronic format that can be used in a variety of teaching and learning initiatives. DPU has made the required preparations to set up the framework for the creation of econtent.

State-of-the-Art AV Studio: To meet the needs of students, the DPU has established two cutting-edge AV recording studios for the creation of its own e-content for learning innovations.

Lecture Capturing System (LCS): DPU uses this system, in which every class is live-recorded and provided for viewing on the Vidyapeeth website. At DPU, the processes for developing, revising, and releasing content are clearly defined. Peer reviewers assess the content and look for plagiarism.

A rigorous process is followed during the creation of new programs, from the need analysis to the creation of the course materials. The three steps of DPU's program development process are courseware development, instructional design, and program formulation. The software used is Shortcut open-source video editor, iMovie video editing for Mac, Audacity and Catwalk by Band lab for audio editing and mixing, Adobe Premier and Adobe Aftereffect. Dr. D. Y. Patil Vidyapeeth, Pune has always strived for quality based holistic and multidisciplinary education. In tune with the strategic plan of the Vidyapeeth and the National Education Policy 2020, Dr. D. Y. Patil Vidyapeeth took a leap ahead by starting two new institutes, namely School of Design and School of liberal Arts, under its ambit in the year 2021. Bachelor programs in both these Institutes were started from 2022-2023 through the involvement of appropriate statutory bodies and councils of DPU. In continuance with implementation of NEP 2020, the School of Allied Health Sciences and School of Science and Technology were established by taking necessary approvals from statutory bodies of DPU with reference to budget, staff recruitment and infrastructure requirements.

In the year 2023-2024, DPU has continued its consistent academic march for upholding NEP 2020 by starting new programs in Medicine, Business Management, Science and Technology, Allied Health Sciences, Liberal Arts and faculty of Design. Total 13 new programs were newly introduced in 2023-2024 through participative involvement which started from stakeholder feedback to actual academic implementation. This process was initiated with the approval of Board of Management/Executive Council and followed by compliance and approval from statutory bodies. Curriculum Committee, Board of Studies, relevant Faculty, Academic Council and Board of Management/Executive Council participate in Curriculum design and implementation of the new Programs.

DPU's Vision 2025 strategic plan reflects a thoughtful and inclusive approach to institutional growth, developed through collaboration among key stakeholders such as Departmental Committees, College Councils, and the Board of Management. Central to the plan's execution was the implementation of the National Education Policy (NEP) 2020 starting in the 2021-2022 academic year, which promoted a multidisciplinary and flexible education model, enabling students to explore diverse fields and integrate knowledge across disciplines.

To further expand its academic offerings, DPU established four new institutes: the School of Design, School of Science and Technology, School of Allied Health Sciences, and School of Liberal Arts. These initiatives, which align with emerging fields and student needs, enhanced the institution's educational reach. By 2022-2023, DPU introduced a variety of new programs, value-added courses, and certifications, continuing its mission to offer holistic, career-oriented education. The introduction of 13 new programs and 1,275 courses in 2023-2024, along with curriculum revisions for 31 existing programs, demonstrated DPU's commitment to keeping pace with industry demands and academic advancements.

DPU's focus on innovation also led to a rise in intellectual property outputs, including patents and copyrights, supporting a culture of research and development. Regular assessments through statutory meetings, IQAC reviews, and quality audits (AAA, ISO, NABH, NABL) ensured the ongoing refinement of its strategic plan, while targeted action plans addressed areas for improvement, securing continuous institutional progress and development.

DPU, Pune operates as a self-financing institution, primarily relying on student fees collected for various programs and services as its main source of revenue. The 'Fee Fixation Committee' is responsible for determining and revising the fee structure as needed. Resource allocation is carried out strategically across various budget categories, with institutional budgets prepared by the respective Heads of institutions. These budgets account for both annual recurring and non-recurring expenditures and are subsequently reviewed by the Finance Committee before being recommended to the Executive Council (formerly the Board of Management) for approval.

The institution's fund mobilization strategy aims to maintain a consistent flow of funds to support maintenance and developmental activities, in alignment with the objectives of the DPU Vision 2025 document.

In addition to student fees, DPU leverages other funding sources, including:

- 1. Hospital income
- 2. Extra-mural research grants and consultancy services
- 3. International Memoranda of Understanding (MoUs), enabling foreign-funded projects

To ensure effective financial management, an Annual Budget exercise is conducted, informed by the previous year's actual expenditures and planned academic and administrative development. The Finance Committee and the Executive Council play key roles in approving and monitoring the budget. Both the approved budget and

6.4.3 - Institution conducts internal and external financial audits regularly

Internal Audit: DPU upholds a rigorous policy for Internal and External Audits, approved by the Finance Committee and the Executive Council (formerly the Board of Management), to ensure

the accuracy of financial transactions and effective management of significant risks. Stringent controls and procedures are implemented, involving multiple staff members in processing documents related to purchases, inventory, cash, bank transactions, maintenance, and development activities. This multilayered system minimizes risks in financial operations. Documents are initially prepared by an accountant and subsequently verified and authorized by senior officials. DPU also follows a pre-audit process for payments, wherein verified documents undergo an audit by a Chartered Accountant before approval.

External Audit: DPU employs an independent external audit mechanism for its financial statements, which are reviewed by a firm of Chartered Accountants. The Executive Council, based on recommendations from the Finance Committee, appoints the external auditor. The auditor conducts a detailed examination of the institution's financial records and evaluates the transactions documented in the ledgers. Upon completing the audit, the auditor issues an Audit Report along with the audited Financial Statements. These are submitted to the Finance Committee and Executive Council for review and approval. Finally, a consolidated financial statement for the Vidyapeeth is prepared.

7.1.3 - Describe the facilities in the Institution for the management of the following types of degradable and non-degradable waste (within 100 - 200 words)

Management of both degradable (biodegradable) and non-degradable waste is crucial for maintaining cleanliness, ensuring sustainability, and complying with environmental regulations. DPU has the facilities necessary to manage both waste in compliance with the guidelines established by the Maharashtra Pollution Control Board (MPCB).

Biodegradable solid waste from the garden and canteen is composted at a vermi-compost plant on the DPU campus. Plastic is prohibited by the Maharashtra government, and DPU has obediently followed this directive. Four sewage treatment plants (STP) in Vidyapeeth can manage liquid waste.1170 m3/day is their aggregate capacity. Two water treatment plants (WTP) with a combined capacity of 650 m3/day and one effluent treatment plant (ETP) with a 50 m3/day total capacity have also been erected. After processing, recycled water is used for gardening and toilets. Hospitals follow standards when it comes to disposing of biomedical waste. Every

day, waste is gathered, put in coloured bags and special containers, and delivered to PCMC's shared disposable facility. DPU possesses the necessary license and MPCB contracts. Vidyapeeth and J.S. Enterprises have an e-waste disposal agreement. The basic protective measures and regulations set forth by the Atomic Energy Regulatory Board (AERB) have been followed to ensure radiation safety. Radiation exposure is monitored via the "Thermoluminescent Dosimeter" badge. The Department of Radiodiagnosis has received approval from AERB for its imaging equipment and layout designs.

D.Y. Patil Vidyapeeth (DPU), Medical College Hospital, a tertiary care facility, provides specialized services for organ donation and multi-organ transplants, offering care and treatment to patients with end-stage organ disease. DPU has conducted the highest number of deceased donations from a single center in the Pune, Maharashtra region by collaborating regularly with government organizations such as NOTTO, SOTTO, ROTTO, and ZTCC to enhance organ donation activities. The success rate of various transplant surgeries makes DPU Medical Hospital a top destination for healthcare. Every year, DPU conducts several workshops to raise awareness about the importance of organ donation through various NSS activities.

Best practice 2: THERAPEUTIC YOGA

At DPU, therapeutic yoga is utilized to address medical conditions and improve structural, physiological, and mental health while alleviating pain and suffering. Techniques such as asanas, pranayama, kriyas, bandhas, and meditation are employed to enhance mental and physical resilience. DPU has received a Grant of 6 lakh for Organizing CME (6days) for Yoga Teachers from Department of AYUSH Ministry, New Delhi, India. In alignment with its recommendations to integrate yoga into schools and workplaces, DPU has successfully established a yoga culture, fostering physical fitness and mental well-being across its community.
