AND WHEREAS Dr. D. Y. Patil Vidyapeeth, Pune (Deemed to be University) 'DPU' has played a very vital role in structuring the educational future of many students. Therefore, it was mandated for all constituent units to establish Health Sciences Education Technology Units in the pattern of Medical Education Units established by the erstwhile Medical Council of India (MCI), now National Medical Commission (NMC). This SOP shall remain in function, till further changes are notified by Dr. D. Y. Patil Vidyapeeth, Pune (Deemed to be University) in this regard.

INTRODUCTION

This SOP will ensure uniform and standardised processes across all constituent units of DPU with regard to planning, design and implementation of faculty development programs to enhance the skills of all faculty across all constituent units of DPU. The SOP will be applicable to all constituent Units of DPU.

The SOP Shall help to define a standard procedure for determining faculty development areas and needs as per roles and responsibilities and as per regulatory requirements. Plan, design and implementation faculty development programs to enhance the skills of all faculty across all constituent units of DPU in alignment with identified needs.







RESPONSIBILITIES


The Director, UCPE&FD at the University and the Heads of respective Constituent Units are respectively responsible for ensuring effective implementation of the SOP.

IMPLEMENTATION

- > The UCPE&FD will function through the UCPE&FD Committee.
- The UCPE&FD Committee shall have representation from the Education Units of all Constituent Colleges as well as IQAC and Research Directorate.
- The University Centre for Professional Education & Faculty Development (UCPE&FD) of Dr. D. Y. Patil Vidyapeeth shall plan, design and conduct faculty development programmes as per need, in keeping with its vision, mission and objectives
- The UCPE&FD shall plan and conduct FDP activities in accordance with global standards for faculty development, based upon training needs analysis by Constituent Units as well as with inputs from the Internal Quality Assurance Cell (IQAC) and new directives from regulatory bodies.
- The Head of the Constituent Unit shall be Chairperson of their respective Education Unit. Members shall include faculty that are enthusiastic and committed and have been trained in educational methodology with adequate representation – rank-wise, subjectwise and from level of PG
- The Education Units of Constituent Units will prepare the training needs analysis of faculty based on their roles & responsibilities at least once a year
- The Constituent Unit shall also prepare 6-monthly FDP Calendar which shall be shared with UCPE&FD by the EU Co-ordinator
- The UCPE & FD shall plan and guide administrative training in coordination with HR Cell of colleges as well as at the University
- The Education Units of the Constituent Colleges will carry out faculty development activities under the guidance and in co-ordination with the UCPE&FD.
- The UCPE&FD shall conduct an impact analysis in collaboration with the Education Units of the Constituent Colleges
- ➤ The UCPE&FD Committee shall meet at least twice a year to review the training activities planned for the academic year.
- ➤ The UCPE&FD shall prepare strategic 5-year academic plan, propose budgetary requirements and staff requirements following a multi-stakeholder needs analysis.
- All Education Units will submit the annual report of their education unit to UCPE&FD. The UCPE&FD shall prepare the Annual Report including activities of all constituent units as well those organised at the University Level

The cycle of training needs analysis, strategic planning, implementation and impact analysis will be followed for each academic year.
